



Waiver and Release Form

In consideration of allowing my child and/or ward to volunteer with Heart In Motion, a nonprofit organization in the Bay Area, I, personally and on behalf of and as the parent and legal guardian, of (child's name) _____, and anyone acting on my or my child's behalf, including but not limited to attorneys, representatives, agents, heirs, executors, administrators, assigns, insurers, predecessors, successors or any other person or entity asserting claims through me, agree to release, indemnify, defend and hold harmless Heart In Motion, and all of their respective directors, officers, shareholders, members, subsidiaries, partners, agents, employees, successors, parents, heirs, executors, administrators and affiliates thereof (collectively, the "Releasees"), from and against any and all claims, suits, losses, damages, expenses, costs, and liabilities (including reasonable attorneys' fees and expenses) which hereinafter may accrue or arise against the Releasees and which in any way arise out of or are in any way related to (a) my child's participation as a volunteer for Heart in Motion, and (b) the use of my child's name, photograph, quotation, and likeness in any advertising or promotions which relate to the Event, and/or any advertising or promotions which are otherwise related to the business activities of the Releasees.

I UNDERSTAND THE DANGER OF PERSONAL INJURY OR DEATH THAT MAY RESULT FROM MY CHILD'S PARTICIPATION AS A VOLUNTEER FOR HEART IN MOTION, AND I, PERSONALLY AND ON BEHALF OF MY CHILD, ASSUME ANY AND ALL RISK THAT IS IN ANY WAY ASSOCIATED WITH, RELATED TO OR OCCURS AS A RESULT OF MY CHILD'S PARTICIPATION IN THE EVENT.

I hereby give Releasees, or any one of them, permission to use my and/or my child's name, photograph, quotations and likeness in any advertisements or promotions of the Releasees, and agree that neither I nor my child shall be entitled to any compensation for any such uses.

I have read this general release and waiver of claims and covenant not to sue and fully understand its contents. I am aware that this is an agreement not to sue the Releasees and constitutes a complete release of liability by me for my child and anyone acting on my or my child's behalf in favor of the Releasees. I acknowledge that I am signing this document of my own free will, with full knowledge of the risks that I and my child are assuming. This document is valid for the duration of my child's membership with Heart in Motion.
